However, only a limited number of cellular targets have been validated for effective use in RNAi-based therapeutics. Consequently, it is essential to develop predictive models of the gene expression responses that should be elicited by therapeutic RNAi. Thus, models that predict the effects of siRNAs or shRNAs on gene expression are needed to help identify therapeutic targets. In preliminary studies, we have used siRNA data from one human cancer cell line (HeLa cells) to predict the effects of siRNAs on global mRNA levels. These models were trained on siRNAs that achieved the highest down-regulation of target mRNA levels in HeLa cells. We now propose to train and test the accuracy of models for a broad set of target genes. Specifically, we propose to train models to predict the effects of siRNAs on mRNA levels in a panel of 9 human cancer cell lines. Models will then be validated by testing their ability to predict mRNA levels in a new set of siRNA treatments in HeLa cells. These data will provide a proof of principle for the ability of the models to predict gene expression responses to RNAi in human cells. In addition, we propose to train and validate models of the effects of shRNAs on mRNA levels in HeLa cells. Finally, we propose to apply the models to predict the efficacy of siRNA and shRNA therapeutics in cancer cells based on mRNA expression responses. In addition, we propose to apply the models to predict efficacy of siRNA and shRNA therapeutics in human tumor cells from cancer patients. These studies will advance our understanding of the influence of the cellular environment on siRNA and shRNA efficacy, as well as the utility of the models to predict efficacies of RNAi therapeutics in human cells. **RELEVANCE:** RNA interference has the potential to be a widely used therapeutic strategy for cancer treatment. This proposal describes a study that will develop and test models of gene expression responses to RNAi in human cells.
